RESOLUTION OF THE OVERSIGHT BOARD FOR THE SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF SAN BERNARDINO APPROVING CHANGES TO FUNDING SOURCES FOR OBLIGATIONS APPROVED BY THE DEPARTMENT OF FINANCE IN RECOGNIZED OBLIGATION PAYMENT SCHEDULE 15-16A FOR PURPOSES OF AVOIDING DEFAULT ON THE CMB-EXPORT \$15 MILLION NOTE

WHEREAS, pursuant to HSC §34177(a)(4), the Successor Agency to the Redevelopment Agency of the City of San Bernardino ("Successor Agency") may, with the prior approval of the Oversight Board, as described in HSC §34179, make payments for enforceable obligations from sources other than those listed in a Recognized Obligation Payment Schedule ("ROPS"); and

WHEREAS, on April 6, 2015, the California Department of Finance ("DOF") approved the Successor Agency's ROPS 15-16A, authorizing the Successor Agency to receive \$18,679,768 in Redevelopment Property Tax Trust Funds ("RPTTF") for the payment of identified enforceable obligations during the ROPS 15-16A period (July 1st through December 31st, 2015); and

WHEREAS, the Successor Agency received only \$16,185,056 in RPTTF for the ROPS 15-16A period, representing a \$2,452,072 shortfall in funding for enforceable obligations authorized by DOF to be paid during the ROPS 15-16A period ("RPTTF Shortfall"); and

WHEREAS, in its letter of August 21, 2015, DOF approved Oversight Board Resolution No. SBOB/2015-01 authorizing the Successor Agency to stipulate to the Interlocutory Judgment in Condemnation with respect to San Bernardino County Superior Court Case No. CIVDS 1302927, San Bernardino County Transportation Commission ("SBCTC") vs. San Bernardino Economic Development Corporation, et al. ("Stipulated Judgment"); and

WHEREAS, based on the Stipulated Judgment the Successor Agency can request an order from the court to obtain the \$1,704,000 in just compensation that was deposited by the

SBCTC with the State Treasurer's Office, and to which the Successor Agency is entitled ("Just Compensation Deposit");

WHEREAS, in order for the Successor Agency to receive the entire the amount of the Just Compensation Deposit, the Stipulated Judgment provides that DOF shall affirm the full amount of the Just Compensation Deposit is required and must be used for the payment of enforceable obligations; and

WHEREAS, due to the RPTTF Shortfall the Successor Agency is unable to pay the remaining balance of approximately \$2,532,813 for Enforceable Obligation No. 14 on ROPS 15-16A by October 1, 2015 (resulting in a default on the CMB-Export \$15 Million Note), unless the Successor Agency obtains and applies the full amount of the Just Compensation Deposit towards the payment of Enforceable Obligation #14; and

WHEREAS, the Oversight Board supports the Successor Agency's plan to use the Just Compensation Deposit to offset a portion of the ROPS 15-16A RPTTF Shortfall for the sole purpose of timely paying the debt service required for enforceable obligation No. 14 (CMB-Export \$15 million Note) and thus avoid a debt service default; and

WHEREAS, all of the prerequisites with respect to the approval of this Resolution have been met.

NOW, THEREFORE, BE IT RESOLVED by the Oversight Board for the Successor Agency to the Redevelopment Agency of the City of San Bernardino ("Oversight Board"), as follows:

Section 1. The foregoing recitals are true and correct and are a substantive part of this Resolution.

Section 2. The Successor Agency's proposed amendment to ROPS 15-16A for the purpose of applying all funds that the Successor Agency receives from the \$1,704,000 Just Compensation Deposit as "Other Funds" to enforceable obligation No. 14 for the purpose of avoiding default on the CMB-Export \$15 million Note is approved.
