The City of San Bernardino is an entitlement jurisdiction that receives Community Development Block Grant (CDBG), HOME Investment Partnerships, and Emergency Solutions Grant (ESG) funds directly from the U.S. Department of Housing and Urban Development (HUD). The City anticipates receiving approximately \$3,307,949.00 in CDBG, \$1,395,707.00 in HOME, and \$290,457.00 in ESG funds

NOTICE IS HEREBY GIVEN that the City that the City of San Bernardino has prepared a draft of the PY2021-2022 CONSOLIDATED ANNUAL PERFORMANCE REPORT (CAPER) as required by the U.S. Department of Housing and Urban Development (HUD). There will be a Public Hearing to review the draft PY2021-2022 CONSOLIDATED ANNUAL PERFORMANCE REPORT on October 19, 2022 at 7:00 p.m.
